



## NAVARRO COLLEGE RN-to-BSN STEPS TO ADMISSION FOR 2026

### **STEP ONE: TO BECOME ELIGIBLE TO APPLY FOR 2026 ADMISSION:**

- Carefully review eligibility requirements for the RN-to-BSN program- see RN-to-BSN website.
- Review the RN-to-BSN Information Session presentation, prior to submitting an application for admission. Link: <https://navarroccollege.instructure.com/courses/36513>
- Apply to Navarro College if you are not already a student here.
  - Make sure you are under the correct degree plan. Prior to acceptance to the program, you should be on: **Pre-Bachelor of Science in Nursing-A.S (AS.BDN)** Link: <https://www.navarroccollege.edu/academics/pre-nursing.html>
  - Send ALL **OFFICIAL** transcripts from EACH college/university attended, to NC Registrar/Admissions.

(All prerequisite courses **SHOULD** be completed before the first day of class; however, accepted students may complete a maximum of 2 courses after enrolled in BSN courses. All prerequisites **MUST** be completed prior to the start of the spring (2<sup>nd</sup>) semester).

### **STEP TWO: APPLY FOR ADMISSION TO THE RN-BSN PROGRAM**

1. Complete the online application. Link:

#### **APPLICATION DEADLINE: APRIL 1, 2026**

- The application is located on our website under the Forms and Documents tab on the left-hand side of your screen – also linked above.
2. Upload transcripts from **EACH** college and/or university you have attended, including Navarro College (Unofficial transcripts/copies of transcripts are acceptable for the RN-BSN application process)
3. A copy of your Degree Audit Transcript **MUST** be uploaded with your application for admission (Degree Audits can be obtained via the NC website under Self-Service). You must be under the correct degree plan. If you are not, contact Admissions Office.

4. Upload a copy the verification report for RN licensure from the TX Board of Nursing. **For recent ADN graduates, acceptance to the RN-BSN program will be contingent upon obtaining RN licensure within one week prior to the start of the fall semester. Failure to provide proof of RN licensure will result in withdrawal from the RN-BSN program.**
5. Upload a copy of a completed Hepatitis B vaccine or positive titer- required for the Hybrid program ONLY.
6. Upload documentation of any community service and or involvement in extracurricular and/or professional activities (if applicable). Contact information for the associated agency must also be provided.

## **What Happens Next?**

- Faculty will rank all qualified applicants. Offers of admission will be sent out by May 1, 2026.
- If you are offered admission, your acceptance letter will include important information regarding important next steps.
